- § 1. A State Lottery (money-prize lottery) may be operated in accordance with Regulations approved by the King. The profit is used in the way the Storting (Norwegian Parliament) decides at any time.

- § 2. The rules concerning the amount of the stakes, the number of draws and the price of each lottery ticket, are laid down in the Regulations.
- § 3. The lottery is administered by a Board comprising three members appointed by the King.

With the approval of the King, the Board may delegate sale of the lottery tickets to a company or institution in accordance with the conditions laid down by agreement.

- § 4. The sum of the prizes shall amount to at least 64 per cent of the stakes. The highest prize is stipulated by the King. Claim for payment of a prize is outdated one year from the date of the draw.
- § 5. The sale of lottery tickets occurs through the relevant institution or company and through agents which the institution or the company accepts. Any person who wilfully sells or attempts to sell lottery tickets for profit, or who assists in so doing, will be punished by fines.
- § 6. This Act enters into force immediately. The Act of 17 June 1925 no.18 concerning the establishment of a State Lottery from the Year 1928 inclusive, is simultaneously repealed.
